Sub.: Drawal of remaining 60% arrears for persons conferred with 'Temporary Status' under Finance Department Resolution no. 31715/F, dtd.04.09.2012 arising out of revision of monthly consolidated remuneration vide FD Resolution no 17815/F, dtd.30.05.2018.

The monthly consolidated remuneration of persons conferred with 'Temporary Status' governed by Finance Department Resolution No. 31715/F, dtd.04.09.2012 was revised vide Finance Department resolution no.17815/F, dtd.30.05.2018 w.e.f. 01.01.2016 and they were allowed to draw the revised remuneration from 01.05.2018. Instructions were issued for drawal of 40% of total arrear remuneration due for the period from 01.01.2016 to 30.04.2018 and for the payment of balance 60% arrear, to await further instructions from Finance Department.

2. Now, Government have been pleased to release the balance 60% arrear remuneration of the aforementioned period of 01.01.2016 to 30.04.2018 in favour of the persons conferred with 'Temporary Status'.
3. Drawal of such 60% arrear remuneration in favour of persons conferred with 'Temporary Status' will be admissible only after drawal of 40% arrear remuneration.
4. The DDO of the establishment should ensure the drawal of 60% arrear remuneration by the end of this financial year, i.e. 31.03.2025.


