Drawal of motor conveyance Advances-
submission of Agreement Bonds.

The undersigned is directed to say that consequent on the changed procedure of the amendment of Rule 248 of O.G.F.R. Vol.I in Finance Department Office Memorandum No.27459F dt.17.5.80 a Government servant in whose favour a motor car/cycle advance is sanctioned, shall, before drawal of the advance execute an agreement bond in Form O.G.F.R. 19 to the Drawing Officer for signature on behalf of the Governor. The Drawing and Disbursing Officer shall record a certificate of executing agreement on the Bill and after disbursement of the advance to the loanee, return the Agreement Bond to the sanctioning authority (Finance Department).

It is regretted that this procedure is not being followed by the Drawing and Disbursing Officers. Strictly and they are not transmitting the Agreement Bonds to the Finance Department even after disbursement of the loans to the loanees as a result of which the Finance Department are putting to a very embarrassing situation in recording the non-drawals and working out the balances.

It has been clearly indicated in the sanction order that the sanction will remain valid for one month from the date of its issue and the mortgage Bond should be executed and submitted to Finance Department within one month from the date of drawal of the advance.

It is, therefore, impressed upon that all Subordinate Offices and the Drawing and Disbursing Officers under their administrative control may please be instructed to adhere to the procedure strictly submitting the Agreement Bonds to the Finance Department within the stipulated time.
