They are also appointed as Additional Commissioner of Sales Tax or Special Commissioner of Sales Tax, respectively, under sub-section (2) of Section 3 of the Odisha Value Added Tax Act, 2004 (Odisha Act 4 of 2005) to exercise such power as may be conferred, and discharge such functions as may be required, by or under the said Act with effect from the date of assumption of their duties within such area as assigned to them by the Commissioner of CT & GST, Odisha, Cuttack.

The officers under this orders of transfer are hereby directed to get relieved by 13.01.2025 failing which they will be deemed to be relieved w.e.f. 13.01.2025 (A.N.).

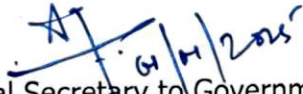

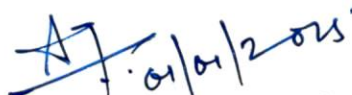
