PREFACE

Nutrition isn't just about food. It's a key driver of health, well-being, and social progress. It influences everything from immunity and cognitive development to economic productivity and gender equality. A well-nourished population is healthier, more resilient, and better equipped to thrive. Hygiene and sanitation also play a crucial role in maximizing the benefits of good nutrition by preventing infections and ensuring proper nutrient absorption, especially among vulnerable groups. Recognizing its far-reaching impact, the United Nations made nutrition a core priority in Sustainable Development Goal 2 (Zero Hunger), which aims to eradicate hunger, improve food security, and promote sustainable agriculture. But achieving these goals requires an integrated approach—one that tackles malnutrition, invests in food systems, and prioritizes health and equality. By addressing nutrition holistically, societies can unlock a future where health, opportunity, and sustainability go hand in hand.

Odisha became the first state in India to introduce the concept of Nutrition Budgeting in FY 2020-21, marking a significant step toward prioritizing nutrition in fiscal planning. The Government of Odisha in collaboration with various government departments and UNICEF, has undertaken this initiative to develop the Nutrition Budget. Additionally, a wide range of stakeholders, such as researchers, PFM professionals, economists, statisticians, academic institutions, civil society organizations, media, and public representatives have contributed to this process, ensuring a well-rounded and evidence-based strategy for achieving better nutritional outcomes. The details of the Nutrition Budgeting including the conceptual descriptions have been explained in the previous editions which are available in the website of Finance Department, Govern of Odisha.

EXECUTIVE SUMMARY

- In 2025-26 Budget Estimates (BE), the Government of Odisha has allocated a sum of Rs.72499.33 Crore under the Nutrition Budget (including Part A and Part B) for the nutritional development and well-being of the people of the state. This marks a 10.03% increase over the Rs. 65,888.65 Crore allocated in the previous BE in 2024-25.
- Out of the total allocation, Rs. 8,285.84 Crore has been earmarked for Nutrition-Specific schemes and programmes (Part A), while Rs. 64,213.48 Crore is allocated to Nutrition-Sensitive components (Part B) in the 2025-26 BE.
- As per 2025-26 BE, in Part A, 11 schemes and Programmes are under Department of Women and Child Development (WCD) and 8 are under Food Supply and Consumer Welfare (FS&CW). Similarly, in Part B, Health & Family Welfare Department (H&FW) manages 49 schemes, while Agriculture & Farmer's Empowerment (A&FE) and Fisheries & Animal Resource Development manage 31 schemes each.
- Department of Women and Child Development (WCD) receives the largest share of Nutrition-Specific allocations at Rs. 2532.25 Crore, followed by FS&CW with Rs. 2,523.49 Crore, and School and Mass Education (S&ME) Department with ₹2132.60 crore. For Nutrition-Sensitive components, significant allocations are made to H&FW Department at Rs. 16,745.87 Crore, A&FE Department at Rs. 11431.57 Crore, and Panchayati Raj and Drinking Water (PR&DW) Department at Rs. 10551.79 Crore.
- In the 2025-26 BE, Programme Expenditure (PE) accounts for 99.99% and Administrative Expenditure (AE) constitutes 0.01% of the total allocation for Nutrition-Specific components (Part A). Likewise for Nutrition-Sensitive components (Part B), PE constitutes 96.40% while AE accounts for 3.60%
- In the current budget estimates, Public Distribution System (PDS) with Rs. 2000.00 Crore, Supplementary nutrition programme (Sakshyam anganwadi and POSHAN 2.0) with 950.00 Crore, and PM POSHAN with Rs. 884.94 Crore are top two Nutrition-specific programmes. While, Jal Jeevan Mission) with Rs.7000.00 Crore and Gopabandhu Jana Arogya Yojana (Rs. 6246 Crore) are two larger programmes in Nutrition-sensitive components.

NUTRITION BUDGETING IN ODISHA

The state's nutrition budget is designed to ensure accountability and transparency in public spending on nutrition for citizens, encouraging effective implementation strategies to deliver better to their nutritional needs. With support from UNICEF, the framework of nutrition budget has been enhancing since its inception. Each year the Finance Department prepares the Nutrition Budget and publishes the Nutrition Budget document (including the budget statement) along with the annual budget.

The Mukhyamantri Sampoorna Pusti Yojana (MSPY) is a key initiative aimed at enhancing the nutritional well-being of women, adolescent girls, and children across the state, with an allocated budget of Rs. 526 Crore. Strengthening this commitment, the state government has introduced the Odisha Pusti Mission with a budgetary provision of Rs. 100 Crore for the financial year 2025-26. This mission is designed to streamline and improve the delivery of nutritional support to the intended beneficiaries.

Further supporting these efforts, the POSHAN Abhiyaan remains a crucial intervention focused on improving nutritional outcomes for women and children with a budget allocation of Rs. 284 Crore by the state government reflecting its continued focus on combating malnutrition and promoting public health.

METHODOLOGY USED IN NUTRITION BUDGETING

All schemes and programmes that constitute the Nutrition Budget have been classified into **Nutrition-specific (Part A)** and **Nutrition-sensitive (Part B)**.

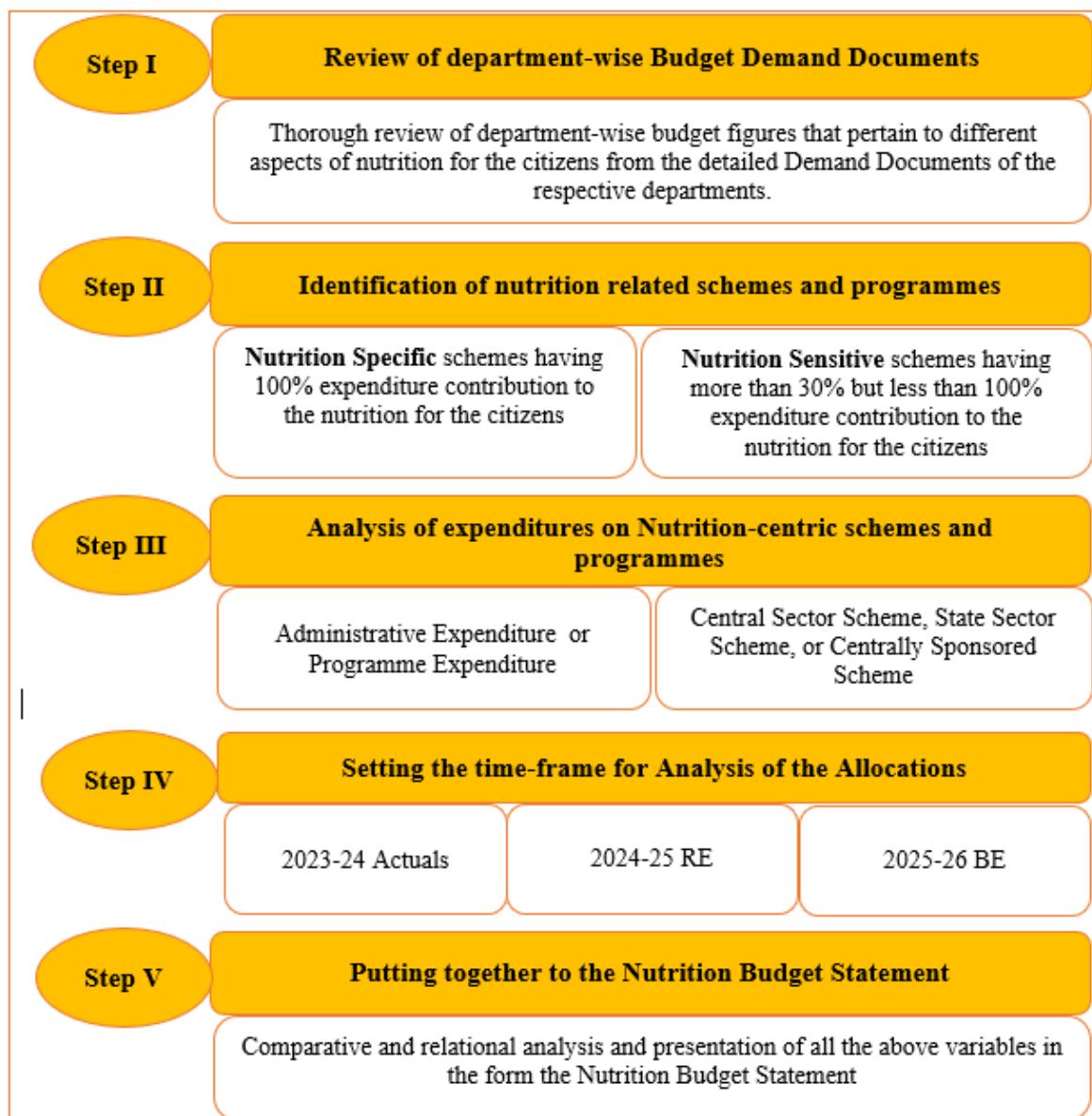
Part A (Nutrition-specific) includes schemes and programmes directly impacting nutrition. The Nutrition-specific interventions address immediate factors affecting foetal and child nutrition, such as adequate food intake, caregiving practices, and reducing infectious diseases. These interventions include exclusive breastfeeding support, nutritious food supply, food fortification, micronutrient supplementation, and treatment of severe malnutrition.

Part B (Nutrition-sensitive) comprises the schemes and programmes that indirectly improve nutrition by enhancing household and community environments and supporting nutrition-specific programs. The Nutrition-sensitive interventions address underlying factors of foetal and child nutrition, such as food security, caregiving resources, healthcare access, and a safe

environment. They also expand the reach and impact of Nutrition-specific interventions. Examples include initiatives in agriculture, sanitation, education, employment, healthcare, resilience support, and women's empowerment.

The timeframe for the analysis of this Nutrition Budget includes the **Actual Expenditures** for the FY 2023-24, the **Revised Estimates** for the FY 2024-25 and the **Budget Estimates** for the FY 2025-26.

Figure 3.1: Distribution of Nutrition-specific Schemes and Programmes across Departments

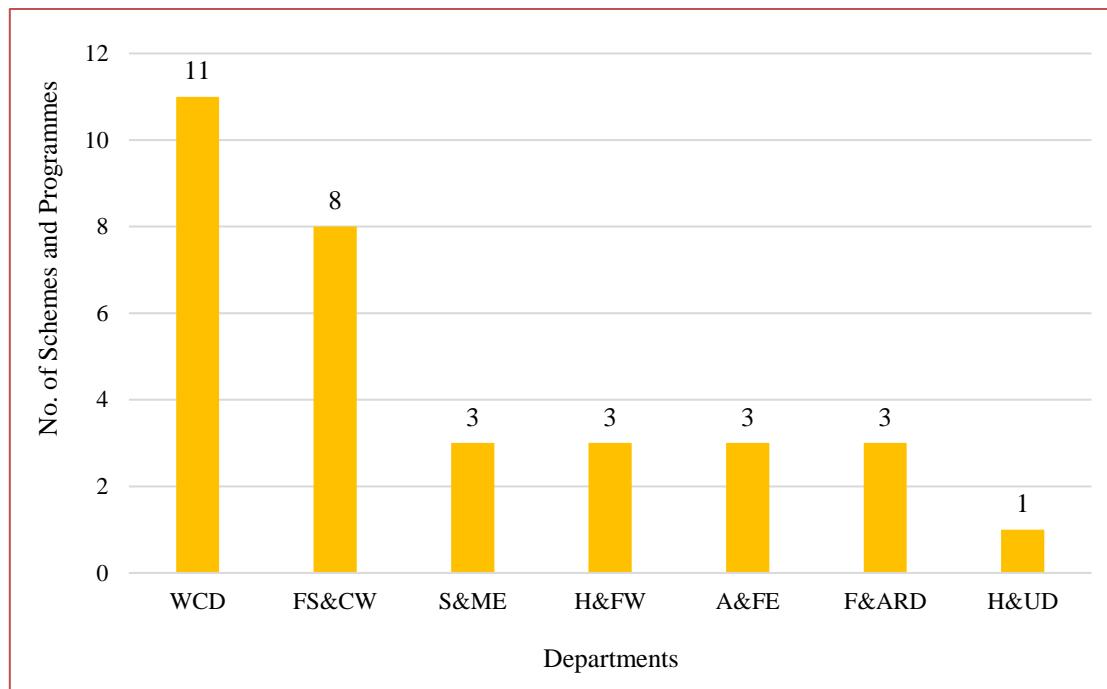


Figure 3.2: Distribution of Nutrition-sensitive Schemes and Programmes across Departments

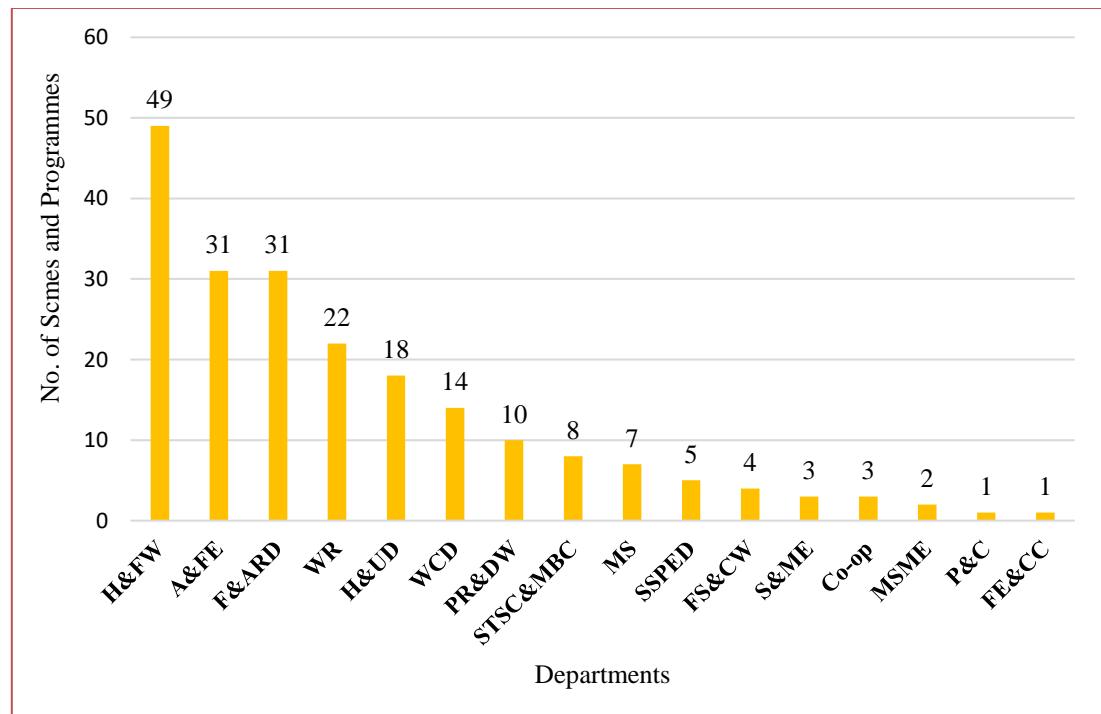


Figure 3.3: Shares of Schemes and Programmes in terms of Nutrition-specific and Nutrition-sensitive Components

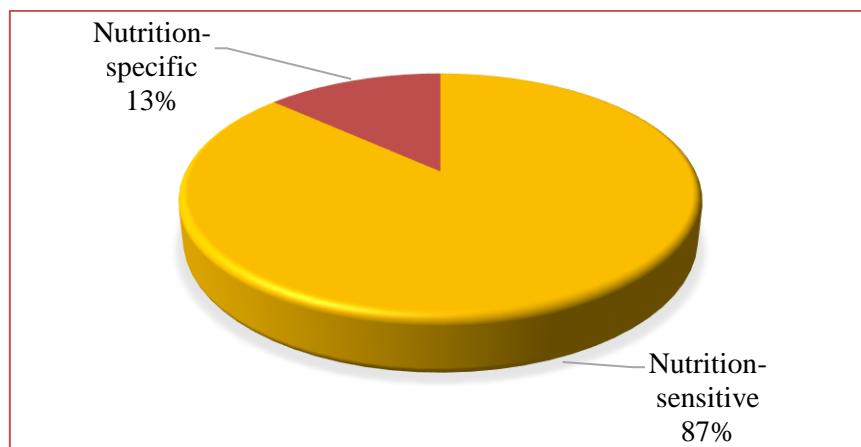


Figure 3.4: Distribution of Nutrition-specific Schemes and Programmes in terms EOM, SSS and CSS

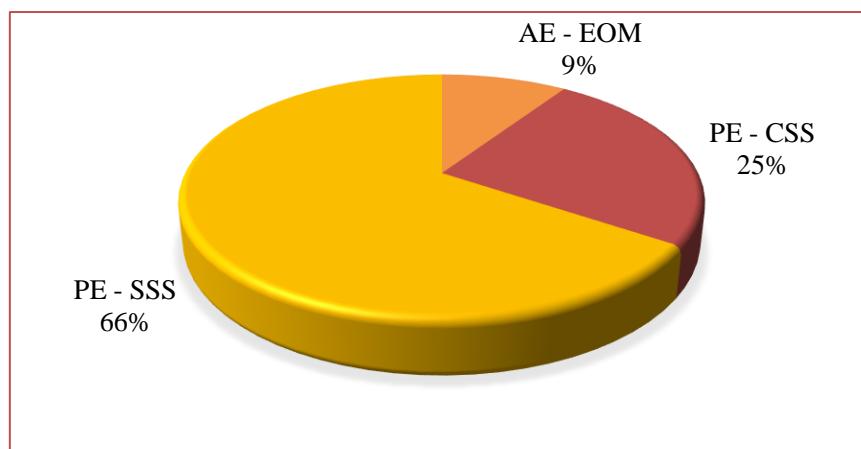


Figure 3.5: Distribution of Nutrition-sensitive Schemes and Programmes in terms EOM, SSS, CSS and CS

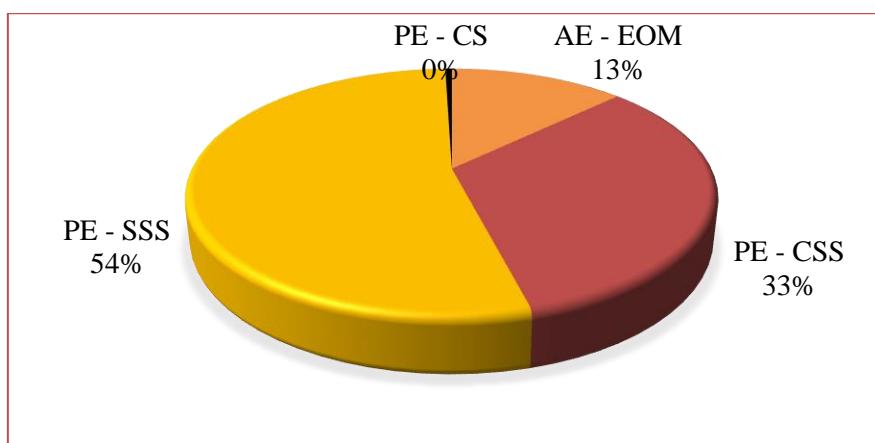
