Bhubaneswar, the 21st March, 2025

No. FIN-CS3-PEN-0009-2024/ 9364 /F; In partial modification of Finance Department Notification No. 44451/F dated 17.09.2005, the State Government has decided to introduce Unified Pension Scheme, as an option under the National Pension System, for the employees of the State Government who are covered under the National Pension System. The **Unified Pension Scheme** shall be applicable, with effect from **01.04.2025**, to such State Government employees who are covered under National Pension System and who choose this option under National Pension System.

The features and guidelines of the Unified Pension Scheme notified by Ministry of Finance (Government of India), vide Notification F.No.FX-1/3/2024-PR. Dated. 24.01.2025, are hereby adopted by the State Government for its employees. However, any reference to Central Government, Central Government employees and Central Civil Services (CC&A) Rules, 1965 made in the above said Government of India Notification shall be deemed to be referring to State Government, State Government employees and Odisha Civil Services (CC&A) Rules 1962 respectively, and such other rules or provisions as applicable to the State Government employees from time to time.

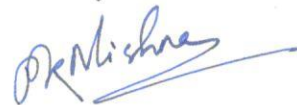

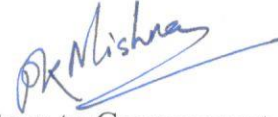
