**NOTIFICATION**

**Sub: Settlement of arrear electricity charges of Government Departments till 31.12.2024.**

Odisha Electricity Regulatory Commission (OERC) vide order dated 22.12.2022 has approved the One-time settlement (OTS) scheme which is valid up to 21.04.2023. Accordingly, Finance Department vide notification No.10142 dated 30.03.2023 had settled the arrears claims by the four DISCOMs up to 31.01.2023. Subsequently, settlement of arrear electricity dues up to 31.01.2024 amounting to ₹41.49 crore was done vide Finance Department Notification No.7027 dated 16.03.2024. Thereafter, settlement of arrear electricity dues up to 31.10.2024 amounting to ₹51.75 crore was done vide Finance Department Notification 4289 dated 07.02.2025. Now, Energy Department has proposed for settlement of outstanding arrear dues amounting to ₹194.71 crore till 31<sup>st</sup> December, 2024 in respect of PR&DW and H&UD Departments which includes pre-vesting arrear of ₹50.95 crore and post-vesting arrear of ₹143.76 crore in favour of GRIDCO and TP-DISCOMs, respectively.

2. The matter was under active consideration of the Government for some time. After careful consideration, Government has been pleased to settle the outstanding dues amounting to ₹120,59,30,465 till 31<sup>st</sup> December, 2024 pertaining to PR & DW Department and H& UD Department which includes pre-vesting arrear of ₹50,95,19,292 and post-vesting arrear of ₹69,64,11,173 in respect of both departments centrally excluding the DPS component.

**3. Settlement of Arrear Energy Charges pertaining to PR &DW and H& UD Departments:**

DISCOMs wise settlement amount towards outstanding arrear dues of PR &DW and H&UD Departments up to 31.12.2024 is tabulated below:

**4. Principles of settlement of arrear Electricity Charges:** The State Government being a model consumer need to set an example for others in clearance of outstanding dues and timely payment of electricity dues to the DISCOMs. As such, the outstanding electricity dues of H&UD Department and PR&DW Department as on 31.12.2024 is to be settled as per the following principles:

- i. Arrear dues pertaining to Pre-vesting period amounting to Rs.50,95,19,292 would be settled centrally by Finance Department.
- ii. Out of arrear dues pertaining to post-vesting period amounting to Rs.143,75,93,075, the dues pertaining to water supply amounting to Rs.69,64,11,173 would be settled centrally by Finance Department as a Special case.
- iii. In future, if any arrear is to be settled, the Administrative Department would propose for Budget provision, in case the CFC/ SFC grants are not sufficient to meet the expenses towards electricity dues for water supply and street lighting.
- iv. The outstanding arrears as on 31.12.2024 amounting to ₹120,59,30,465 which is payable to GRIDCO & TP-DISCOMs shall be debitible to 'Demand No.05-2052- Secretariat General Service-00-EOM-090-Secretariat-0488 Finance Department-78487-One-time Settlement arrear electricity dues' in 2024-25(BE).
- v. The deadlines for sanctioned/release of funds, issue of allotment etc have been relaxed and revised up to 31.03.2025.
