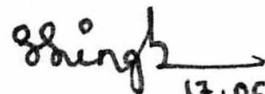

He is also appointed as Deputy Commissioner of Sales Tax, under sub-section (2) of Section 3 of the Odisha Value Added Tax Act, 2004 (Odisha Act 4 of 2005) to exercise such power as may be conferred, and discharge such functions as may be required, by or under the said Act with effect from the date of assumption of his duties within such area as assigned to him by the Commissioner.

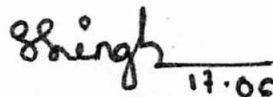

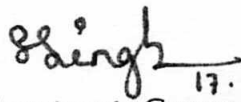

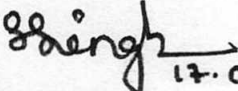
