Subject: Reversion of Sri Sanjeet Suman from Odisha Financial Service (OFS-I(JB)) to Odisha Taxation & Accounts Service (OT&AS)

WHEREAS, Sri Sanjeet Suman, OT&AS, was promoted on an ad-hoc basis to the post of OFS-I(JB) vide Finance Department Notification No. 10726, dated 02.04.2025.

AND WHEREAS, the OPSC has not concurred with the said promotion due to a court case pending against the officer, wherein the JMFC-I Court, Bhubaneswar, on order dated 20.02.2025, has taken cognizance of a matter based on Charge Sheet No. 29/25 filed by the Airfield Police Station, Bhubaneswar, against Sri Sanjeet Suman.

AND WHEREAS, considering the non-concurrence by OPSC and the judicial proceedings, it has been deemed necessary to revert the officer to his substantive post in the Odisha Taxation & Accounts Service.

NOW, THEREFORE, the Government of Odisha, in exercise of the powers conferred under the Rule 12(2) of the Odisha Finance Service Rules, 2011 and other applicable regulations, hereby orders the reversion of Sri Sanjeet Suman, presently serving as OFS-I (JB), to his substantive post in the Odisha Taxation & Accounts Service (OT&AS) with immediate effect.

This notification is issued in the public interest and in compliance with the administrative and legal requirements.

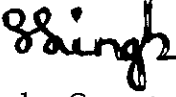

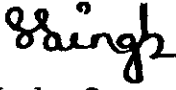

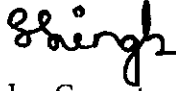
