**Madam/Sir,**

Inviting a kind reference to the subject cited above, I am to say that in the 2<sup>nd</sup> meeting of State Level Committee (SLC) on Standardization, held under chairmanship of Chief Secretary, Odisha on 14.05.2025, among other things, it was decided for including provisions in State Procurement Policy to promote use of ISI marked products to ensure quality in public procurement.

As per Rule-202 (iii) of Odisha General Financial Rules (OGFR), 2023 where applicable, the technical specifications shall, to the extent practicable, be based on the national technical regulations or recognized national standards or building codes, wherever such standards exist or a procuring entity may, for the reasons to be recorded in writing, adopt any other technical specification, as per the scheme conditions.


It is, therefore, requested that the Departments/ Organisations under your control be advised to promote ISI marked product in procurement in order to ensure procurement of better quality of goods/products.






