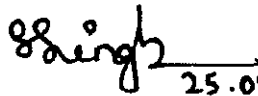
Sir/Madam,

This may be treated as **most urgent**.

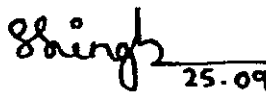

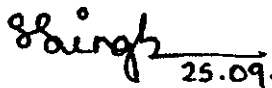

Ref: 1. GA department letter No.3023 dated 28.01.1999, letter No.1524(e) dated 12.01.2001 (Regarding recommendation for appointment to OFS)- Copy enclosed

Sir,

In reference to the letters cited above and pursuant to the decision taken during the meeting of the Committee held on 09.09.2025 for implementation of the Hon'ble Supreme Court order dated 25.07.2025 in IA No. 54006/2024 arising out of WP(C) No. 140/2013, Government has decided as follows for officers ranked from Sl. No. 79 to Sl. No. 150 in the merit list of the Odisha Civil Service Examination, 1997:

1. All concerned officers ranked from Sl. No. 79 to Sl. No. 150 in the merit list of the OCS Examination, 1997 are required to submit their service preferences by choosing one of the following options:
 - a. Opt for allocation to the Odisha Administrative Service (OAS) cadre.
 - b. Opt for allocation to the Odisha Finance Service (OFS) cadre.
 - c. Opt to continue in their presently allocated service.
2. The options must be submitted positively by 08.10.2025 to the GA & PG Department through the respective cadre controlling Department of the officer concerned, failing which the officer will be deemed to have opted to continue in his/her current service allocation.
3. Once such options are submitted, they shall be final and binding on the officers concerned. Officers who fail to submit their options by the stipulated deadline shall be deemed to have opted to continue in their current service allocation, without any further right to change.
4. Based on the options received, the Government in GA & PG Department, in consultation with the Finance Department, will create the necessary number of

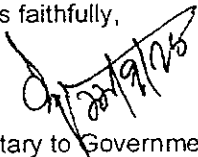
supernumerary posts in the OAS and/or OFS cadres. These posts will be effective retrospectively from the date of appointment of the respective juniors of the concerned officer as per the merit list.

5. Officers opting for transfer to OAS or OFS cadres will be granted notional appointment from the date of appointment of their newly-fixed juniors in the merit list of the OCS Examination, 1997.
6. The officers concerned will be eligible for notional promotion to higher grades in the chosen cadre effective from the dates their newly-fixed juniors were promoted, subject to their fulfilment of the eligibility criteria prescribed under the relevant promotion rules. For such officers, the requirement of undergoing training & passing mandatory Departmental Examinations for subsequent confirmation in the OAS or OFS cadre shall be relaxed by the concerned cadre controlling Departments under Government order.
7. Notional promotions granted under this process will not carry any entitlement to arrear financial benefits. Pay fixation will be done on a purely notional basis to adjust service records appropriately without monetary arrears.
8. If a vacancy exists in the highest eligible grade/rank to which an officer is notionally promoted (at par with his newly-fixed junior), the supernumerary post will be adjusted against that vacancy. If no such vacancy exists, the supernumerary post will continue until a future vacancy arises (due to retirement, promotion, etc.) in that grade/rank, at which point it will be adjusted.
9. It has been decided that this specific cadre allocation process is being undertaken in compliance with a judicial order and shall not be cited as a precedent for future cases.

It is, therefore, requested to kindly communicate this decision urgently to all officers (ranked from Sl.No.79 to 150 in the merit list of the Odisha Civil Service Examination, 1997) under your control with instructions to the officers concerned to exercise their options positively by 08.10.2025.

This may kindly be treated as most urgent.

- (ii) The certificate in support of the medical fitness.

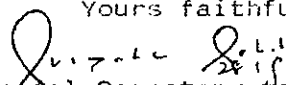
