Bhubaneswar the 4th/12/2025

No-PT1-FIN-TRY-MISC-0002-2020/ 33596/F. In exercise of the powers conferred by Rule-1-A of the Odisha Treasury Rules, the State Government, after consultation with Principal Accountant General (A & E), makes the following amendment under the Odisha Treasury Code, Volume-I, namely:

2. For Subsidiary Rule-258 (2), the following shall be substituted: -

"Unless in any case the Auditor-General directs otherwise, sub-voucher for more than Rs. 10,000 shall be submitted to the Accountant-General, Odisha."

3. In Subsidiary Rule-479A, the words *"The Administrator of the Personal Ledger Accounts shall furnish the monthly compiled accounts of receipts and withdrawals supported by vouchers of the said Account to the Accountant General, Odisha in the form given below by 10th of the following month."* shall be substituted by the words *"The Administrator of the Personal Ledger Accounts shall furnish the monthly compiled accounts of receipts and withdrawals supported by vouchers of more than Rs.5,000 of the said Account to the Accountant General, Odisha in the form given below by 10th of the following month."*

4. This has been concurred in by the Principal Accountant General (A&E), Odisha vide Finance Department File No: PT1-FIN-TRY-MISC-0002-2020.

5. This shall come into force from the date of its publication in the Odisha Gazette.


