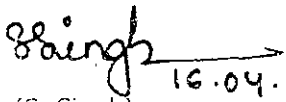

They are also appointed as Assistant Commissioner of Sales Tax under sub-section (2) of Section 3 of the Odisha Value Added Tax Act, 2004 (Odisha Act 4 of 2005) to exercise such power as may be conferred, and discharge such functions as may be required, by or under the said Act with effect from the date of assumption of their duties within such area as assigned to them by the Commissioner.

The officers under orders of transfer are hereby directed to get relieved within fifteen days of receipt of this order.

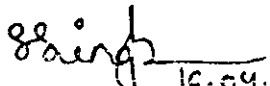

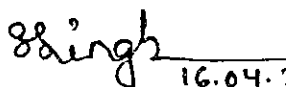

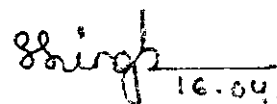
