Madam/Sir,

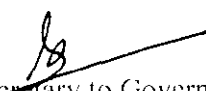
In inviting a reference to the subject cited above, I am directed to say that State Government have issued guidelines from time to time regarding sanction of interest-free Electric Vehicle (EV) Advance in respect of State Government employees, in pursuance of the Odisha Electric Vehicle Policy-2021 notified by C&T (Transport) Department.

2. The aforesaid policy, initially valid up to 31.12.2025, was subsequently extended up to 31.03.2026, and accordingly, this Department vide Letter No. 3182/F dated 04.02.2026 had prescribed the final timelines for availing the interest-free EV advance.

3. Now, it is hereby informed that the **interest-free advance facility for purchase of Electric Vehicles (EVs) by State Government employees shall stand discontinued w.e.f. Financial Year 2026-27, i.e., from 01.04.2026.**

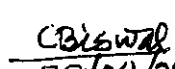
4. It is, therefore, requested to bring the above instructions to the notice of all concerned under your administrative control for strict compliance.
