OFFICE MEMORANDUM

Bhubaneswar, the 18 th April, 1985.

Subject:- Surrender of Earned Leave in lieu of leave salary and allowances - clarification regarding.

In terms of Finance Department Resolution No. 25892/F., dt. 24.5.78, a Government servant may be allowed to surrender 30 days of earned leave for encashment during a block period of 24 months. Instances have come to the notice of Government that in some cases Government servants could not apply for the benefit of surrender leave within the block period for the reasons beyond their control and have accordingly come up with the request to allow them the benefit of surrender leave for the block period in question. In course of time much relaxation has been made in the matter of grant of surrender leave and the Government servants are entitled to this benefit as a matter of course, if they have got the required number of E.L. at their credit.

2. In consideration of the facts stated above, Governor has been pleased to decide that the Government servants who could not apply for the benefit of surrender leave during a particular block period for the reasons beyond their control may be allowed the benefit within six months from expiring of that block period if they apply for the benefit within 3 months from the date of the commencement of next block period.

3. Payment of leave salary for the earned leave to be surrendered in the above cases shall, however, be equivalent to the pay and allowances the officer was entitled to for the last but one (i.e., 23rd) month of the block period in respect of which the benefit of surrender of leave is granted subsequently.

4. This decision will come in force from the date of issue. Cases pending on the date of issue of the order may be regulated as per the above decision. Cases already decided will not, however, be reopened.
