S.R.O. No. – In exercise of the powers conferred by sub-section (1) of section 9 and sub-section (5) of section 15 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017), the State Government, on the recommendations of the Goods and Services Tax Council, and in supersession of notification of the Government of Odisha in the Finance Department No. 34475-FIN-CT1-TAX-0002/2020, dated the 10th December, 2021, published in the Extraordinary issue No.2049 of the Odisha Gazette, dated the 10th December, 2021 bearing S.R.O. No. 479/2021, do hereby make the following further amendments in the notification of the Government of Odisha in the Finance Department No. 19829-FIN-CT1-TAX-0022/2017, dated the 29th June,2017, published in the Extraordinary issue No.1133 of the Odisha Gazette, dated the 29th June,2017 bearing S.R.O. No. 295/2017, namely:–

In the said notification, -

- a. in Schedule I – 2.5%, serial number 225 and the entries relating thereto shall be omitted; and
- b. in Schedule II – 6%, after serial number 171 and the entries relating thereto, the following serial number and the entries against it shall be inserted, namely: -

“171A1	64	Footwear of sale value not exceeding Rs.1000 per pair.”
