No. – Whereas, Shri Sushil Kumar Lohani, IAS was appointed as the Commissioner of Entertainment Tax in the notification of the Government of Odisha in the Finance Department No.33474-FIN-CT1-TAX-0005-2019 dated the 30th September, 2019 under sub-section(1) of section 3 of the Odisha Entertainment Tax Act, 2005 (Odisha Act 7 of 2006);

And whereas, the Odisha Entertainment Tax Act, 2005 has been repealed by the Odisha Goods and Services Tax Act, 2017 with effect from the 1st July, 2017;

And whereas, Shri Sanjay Kumar Singh, IAS is appointed as Commissioner of Commercial Taxes & GST vice Shri Sushil Kumar Lohani, IAS in the office order of the Government of Odisha in the GA & PG Department No.24184/AIS-I dated the 26th August, 2022;

And whereas, certain matters under the Odisha Entertainment Tax Act, 2005 so repealed is saved under sub-sections (2) and (3) of section 174 of the Odisha Goods and Services Tax Act, 2017;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 of the Odisha Entertainment Tax Act, 2006 (Odisha Act 7 of 2006) read with sub-sections (2) and (3) of section 174 of the Odisha Goods and Services Tax Act, 2017 (Odisha Act 7 of 2017) and section 5 of the Odisha General Clauses Act, 1937(Odisha Act 1 of 1937), the State Government do hereby appoint Shri Sanjay Kumar Singh, IAS , Commissioner of Commercial Taxes & GST, Odisha to be the Commissioner of Entertainment Tax, Odisha with effect from the date he assumes charge as such and he shall exercise such powers and discharge such

functions as are or may be conferred or imposed by or under the provisions of the Odisha Entertainment Tax Act, 2005.
