S.R.O. No. –Whereas, the Odisha Sales Tax Act, 1947 has been repealed by the Odisha Value Added Tax Act, 2004 with effect from the 1st April, 2005;

And whereas, Shri Sanjay Kumar Singh, IAS is appointed as Commissioner of Commercial Taxes & GST vice Shri Sushil Kumar Lohani, IAS in the Office Order of the Government of Odisha in the GA & PG Department No. 24184/AIS-I, dated the 26th August, 2022;

And whereas, certain matter under the Odisha Sales Tax Act, 1947 so repealed is saved under sub-sections (2) of section 104 of the Odisha Value Added Tax Act, 2004;

Now, therefore, in exercise of the powers conferred by sub-section(1) of section 3 of the Odisha Sales Tax Act, 1947 (Odisha Act 14 of 1947) read with sub-sections (2) of section 104 of the Odisha Value Added Tax Act, 2004 (Odisha Act 4 of 2005) and section 5 of the Odisha General Clauses Act, 1937 (Odisha Act 1 of 1937), the State Government do hereby appoint Shri Sanjay Kumar Singh, IAS, Commissioner of Commercial Taxes & GST, Odisha to be the Commissioner of Sales Tax, Odisha with effect from the date he assumes charge as such and he shall exercise such powers and discharge such functions as are or may be conferred or imposed by or under the provisions of the Odisha Sales Tax Act, 1947.
