OFFICE MEMORANDUM

Bhubaneswar, the 2nd June, 1982.

Subject:- Admissibility of allowance of Compensatory nature during the period of leave surrendered for the benefit of encashment.

In Finance Department Office Memorandum No.58973/F. dated 17.12.79, it was clarified that unless the conditions prescribed under Rules 100 and 101 of the Orissa Service Code together with the "Notes" thereunder are complied with, no compensatory allowance including House Rent Allowance would be admissible during the period of leave surrendered for the benefit of encashment. Doubts have been raised in certain quarters as to the types of allowances of compensatory nature actually admissible in respect of leave surrendered for encashment. After careful consideration of the issue, Government have been pleased to decide as follows :-

2. The provisions under Rules 100 and 101 of the Orissa Service Code relate to regular leave availed under the Orissa Leave Rules, 1966 and do not include the scheme for surrender of leave for the purpose of encashment. Accordingly House Rent Allowance, Special Construction Allowance, Non-practising Allowance and such other allowances of compensatory nature as are allowed for specific purposes and paid during the period of duty or leave actually availed will not be admissible in respect of leave surrendered for encashment.
