No. 751/95—In exercise of the powers conferred by sub-section (1) of Section 5 of the Orissa Sales Tax Act, 1947 (Orissa Act 14 of 1947), the State Government do hereby direct that the following amendments shall be made to the notification of the Government of Orissa in the Finance Department No. 21987—CTA-98/90-F., dated the 30th June 1980, namely :—

AMENDMENTS

In the Schedule to the Said notification,—

- (a) in the entries against Serial No. 8, for the words "Twelve per cent" appearing in column (3), the words "Twenty per cent" shall be substituted;
- (b) in the entries against Serial No. 9, for the words "Sixteen per cent" appearing in column (3), the words "Twenty per cent" shall be substituted;
- (c) in the entries against Serial No. 37, for the words "Four per cent" appearing in column (3), the words "Six per cent" shall be substituted;
- (d) in the entries against Serial No. 57, for the words "Sixteen per cent" appearing in column (3), the words "Twenty per cent" shall be substituted;
- (e) in the entries against Serial No. 68, for the words "Six per cent" appearing in column (3), the words "Eight per cent" shall be substituted;
- (f) in the entries against Serial No. 76, for the words "Sixteen per cent" appearing in column (3), the words "Twenty per cent" shall be substituted;
- (g) in the entries against Serial No. 78, for the words "Sixteen per cent" appearing in column (3), the words "Eighteen per cent" shall be substituted; and
- (h) in the entries against Serial No. 90, for the words "Twelve per cent" appearing in column (3), the words "Sixteen per cent" shall be substituted.
