S.R.O. No. 1116/84—In exercise of the powers conferred by sub-section (3) of section 206 of the Code of Criminal Procedure, 1973 (2 of 1974), the State Government do hereby specially empower the following Magistrates to exercise the powers conferred by sub-section (1) of the said section in relation to any offence, which is compoundable under section 320 of the said Code or any offence punishable with imprisonment for a term not exceeding three months or with fine, or with both, where the Magistrate is of opinion that having regard to the facts and circumstances of the case, the imposition of fine only would meet the ends of justice—

- S. R. O. No. 1118/84—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Orissa is pleased to make the following rules further to amend the Orissa Service Code, namely:—
 - (i) These rules may be called the Orissa Service Code (1st Amendment) Rules, 1984.
 - (ii) They shall come into force on the date of their publication in the Orissa Gazette.
 - 2. In the Orissa Service Code, in Rule-194, after clause (e) and 'Note' thereunder, the following clause shall be inserted, namely:—
 - "(f) No maternity leave shall be granted to a female Government servant for the third and subsequent issues."
