The undersigned is directed to invite a reference to Finance Department Memo. No. 49304 (130), dated the 25th October 1979 in which it has been stated that Heads of Departments will send a consolidated report of the subscribers who are due to retire during the course of next year to Accountant-General. Orissa by the 30th September each year after collection information from the Heads of Offices under their control. But it has been brought to the notice of Government by the Audit Office that the Heads of Department are not furnishing such lists to the Audit Office for which settlement of G. P. F. cases of retired Government servents are being delayed causing undue hardship to them.

It is, therefore, impressed upon all Heads of Departments that they should ensure submission of such lists in duplicate with G. P. F. Account Nos. of the subscribers who are due to retire within the course of next year to the Audit Office regularly by 30th September each year after collecting information from the concerned Head of Offices under their administrative control with a view to enable the Accountant-General to review the G. P. F. accounts of the retiring subscribers and to finalise balance for final payment in fime. Such list shall contain name of the subscriber G. P. F. Account No., date of superannua-tion and should be prepared in separate sheets according to G. P. F groupwise (suffix with) as is done in case of G. P. F. recovery schedules.
