S. R. O. No. 1061/95—In exercise of the powers conferred by section 6 of the Orissa Sales Tax Act, 1947 (Orissa Act 14 of 1947), the State Government do hereby make the following amendment further to amend the notification of the Government of Orissa in the Finance Department No. 20205—CTA-14/76-F., dated the 23rd April 1976, namely:—

**AMENDMENT**

In the schedule to the said notification, after serial No. 35-G, the following new serial and entries shall be inserted under appropriate columns, namely:—

35-H	Sale of Fly-ash based Asbestos Cement Sheets containing not less than 25% of Fly-ash (by weight) manufactured by M/s. Utkal Asbestos Ltd., Dhenkanal.	<p>(i) The exemption shall be allowed for a period of five years.</p> <p>(ii) The Fly-ash content of Asbestos Cement Sheets manufactured by M/s. Utkal Asbestos Ltd. shall not be less than twenty-five per cent by weight.</p> <p>(iii) If at any time, during the period of exemption allowed, it comes to the notice of the State Government that the Fly-ash content of the Asbestos Cement Sheets manufactured by M/s. Utkal Asbestos Ltd. is less than twenty-five per cent by weight, the exemption so allowed, will be withdrawn and the Sales Tax exemption already availed by them shall be realised.</p> <p>(iv) The basis of determining the extent of utilisation of Fly-ash in the manufacture of Asbestos Cement Sheet by M/s. Utkal Asbestos Ltd., shall be certified by the Assistant Collector, Central Excise and Customs, Cuttack.</p>

S. R. O. No. 1131/95—Whereas the draft of certain rules further to amend the Orissa Sales Tax Rules, 1947 was published as required by sub-section (1) of Section 29 of the Orissa Sales Tax Act, 1947 (Orissa Act 14 of 1947), in the extraordinary issue No. 825 of the *Orissa Gazette*, dated the 15th July 1995 under the notification of the Government of Orissa in the Finance Department No. 26476—CTA-78/95-F., dated the 1st July 1995 as S.R.O. No 529/95 inviting objection and suggestion from all persons likely to be affected thereby till the expiry of a period of fifteen days from the date of publication of the said notification in the *Orissa Gazette*;
