Calculation of interest on loan in respect of long term advances like House Building Advance and Motor Car Advances etc.

Bhubaneswar, the 187 Sep. 1979.

Sir,

. I am directed to invite a reference to your letter No. 10840 dated 24.5.79 and to say that as per rule (6) of the House Building Rules of Government Drissa and xwx Para 217 of the O.G.F.R., interest on House Building Advance is to be calculated on the balance outstanding on the last day of each month. The balance outstanding or the last day of each month is struck taking monthly recovery deposit into account. Unless the recovery made from pay of the Government servants, on deputation to Corporations and Autonomous bodies etc. are deposited with Government under aporr late Head of Account soon after the recovery is effected. for the month, from the deputed officer's Pay, the same cannot be taken into consolidated fund of the State of Orissa. The recovery of the amount by the Board does not amount to deposit in the consolidated fund of the State. The date of the deposit of the amount in Government account by the Roard will be taken as the date of the deposit in the consolidated fund of the State. Therefore interests have to be charged for the time gap between the actual date of the recovery of the amount from the concerned employee and the remittance of the same by the Board into the consolidated fund of the State. Gap of few days, in the process of deposit, will no doubt be ignored.

The recovery towards House Building Advance were regularly effected by theBoard from the pay of Sri B.K.Patnaik, Ex-Superintending Engineer. But the Orissa State Electricity Board without depositing the same in the treasury held up the amount for abnormally long period. The Board, for example, deposited Rs.7,000/- on Ist July, 74 and Rs.13,500/-

on 1.1.75 in the Bhubaneswar treasury. Therefore, interests for delayed remittance, into the consolidated fund of the State is to be paid by the Board and not by Sri Patnaik from whom recovery has been regularly effected. They are, accordingly requested to deposit an amount of Rs.3,002.90 (Rupees three thousand two and ninety paise) as interest on account of the delayed remittance of recovery made from Sri B.K.Ps

The Accountant General, Orissa is being informed of the decision.
