#### OFFICE MEMORANDUM

Bhubaneswar, the 28th November 1989

Subject—Payment of Dearness Allowance to State Government Employees etc.

In pursuance of Government Resolution No. 42541-F., dated the 28th November 1989, the Governor has been pleased to sanction one instalment of Dearness Allowance to the State Government Employees in the Revised Scales with effect from the 1st July 1989 at the following rates.

NOTE—The payment on account of Dearness Allewance involving fractions of 50 paise and above shall be rounded of to the next higher rupee and the fractions of less than 50 paise shall be ignored.

2.1. These orders shall apply to the Government employees—(a) 'who have come over to Revised Scales of Pay, 1939 and (b) also to those who have retained the scale of pay existing prior to the 1st January 1985 and will continue to retain the same scale of pay after the 1st May 1989 unfil lhey come over to the Reviscil case of former, basic pay for the purpose of coming under (a) the basic pay for the purpose of calculation of Dearness Allowance shall be the pay as defined in Rule 3B(n)(i)ol the Orissa Service Code. In case of employees coming under (b) it will include in addition to pay in the pre-revised scales las defined in Rule 33 (a)(i) of the Orissa Service Code, Dearness Allowance and Additional Dearness Allowance :15 admissible on such pay as on the 1st January 1986.

2.2. These orders shall also apply to the members of the O.S.J.S. (Sr. Br.) who elect or are brought on the revised scales of pay as adopted in Home Department Reso-Jution No. 74176-S.J.S., dated the 9th November 1987 with effect from the 1st January 1986 and slso to those who elect to retain the scales of pay which were in force prior to the 1st January 1986. In case of former, basic pay for the purpose of calculation of Dearness Allowance phyable under new principle shall be the pay as defined in Rule 33 (a)(i) of the Orissa Service Code. In the case of later., it will include in addition to pay as defined in Rule 33(a)(i) of Orissa Service Code in the Pre-revised Scales, Dearness Allowance Additional Dearness Allowance and admissible on such pay as on the 1st January 1986.

3. The mode of payment of Dearness Allowance admissible under these orders shall be as follows:—

> (a) The amount of Dearness 'Allowance payable for the period from the 1st 'July '1989 to the 31st December 1989 in accordance with this Office Memoraudum shall be impounded and credited to the General Provident Fund Accounts of the beneficiary employees.

- (b) In case of Members of Oriasa Superior Judicial Services (Senior Branch) the arrear amount of Dearness Allowance in accordance with this office memorandum for the period from the 1st July 1989 to the 31st December 1989(shall be impounded and credited to their respective General Provident Fund Accounts of the concerned employees.
- (c) In case of Non-Government Frimary School Teachers, Employees of Aided Educational Institutions and Urban Local Bodies, the arrear amount of Dearness Allowance for the period from the 1st July 1989 to the 31st December 1989 shall he impounded and credided to the respective Provident Fund Accounts of the concerned employees.
- (d) The State Undertakings/Corporations/Universities and other Autonomous Organisations, those who have been granting Dearness Allowance from time to time to their employces at the State Government rates, the amount of Dearness Allowance payable to them for the period from the 1st July 1989 to the 31st December 1989 shall not he paid in cash and shall be deposited by the cmployer favour of the concerned in employees in Postal Time Deposit Corlificate for a Account or minimum period of one year. In a Time Deposit 'Account or in any certificate the minimum deposit is Rs. 50 or multiple thereof. Where, however, any instalment or arrears of instalments exceeds Rs. 50 or multiple thereof the difference hy which the amount exceeds Rs. 50 or multiple thereof he paid in each. The organisa« tions referred to above who have not yet crediled arrear amounts of Dearness Allowance as per the terms and conditions envisaged in para, 3(c) of Finance Department O. M. No. 30833-F., dated the filh August 1989 shall not draw this instalment of Dearness Allowence.

- (e) The dues on account af these orders, in respect of employees who have already refired or consect to be in Government service or fift required to subscribe during last 4 (four) months of service shall be paid in cash. In respect of employees who have no General Provident Fund Account, new account shall be opened immediately in relaxation of the relevant rules where necessary and thereafter the dues shall be credited.
- (f) However, in case of work'-charged and job-contractemployees employees lo Consolidation. Survey and Settlement Organisa. tions, the amount payable for the period from the 1st July 1989 to the 31st December 1989 shall not be paid in cash and shall he deposited by the employer in favour of the concerned employees in Postal Time Deposit Accounts or Certificates for a minimum period of one year. In a Time Deposit/Account or in any certificate the minimum deposit is Rs. 50 or multiple there of. Where, wowever, any instalment or arrears of instalments exceeds Rs. 50 or multiple thereof the difference by which the amount exceeds Rs. 50 or multiple thereof be paid in cash. The dues on account of Deamess 'Allowance in receipt of such employees who have retired or ceased, to be in service shall be paid in cash.
- (g) The amounts creditable to the Provident Fund Accounts of the Employees for the period from 1st July, 1989 to the 31st Deceshould be drawn mber, 1989 from the appropriate head and credited to the General Provident Fund Account by the end of March, 1990 and the Pay bill for the month of March, 1990 shall not be entertained by the Treasuries/Special Treasuries/ Sub-Treasuries concerned unless a cortificate is recorded by the Drawing and Disbursing Officers on the body of the Pay Bill that

the enhanced arrear Dearness Allowance creditable to the Provident Fund Accounts of the employees as per this Office Memorandum have been drawn and credited to the Provident Fund Accounts of the concerned employees.

(h) In case of Non-Government Primary School Teachers and employees of Aided Educational Institutions the arrear amounts of Dearness Allowance for the period from the 1st July 1989 to the 31st December 1989 should be impounded and credited to the respective Provident Fund Accounts of the concerned employees by the enc of March, 1990 and the pay bill for the month of March, 1990 shall not be entertained by the Treasuries/Special Treasu r i e s/ Sub-Treasuries concerned unless a certificate is recorded by the Drawing and Disbursing Officers on the body of the Pay Bill that the enhanced arrear Dearness Allowance creditable to the Provident Fund Accounts of the employees as per this Office Memorandum have been drawn and credited to the Provident Fund Accounts of the concerned employees. The Education & Youth Services Department and Treasuries and Director of Inspection, Orissa should therefore ensure that the amounts are credited to the Provident Fund Accounts of such employees in time. Officers of/under the Edu-Youth cation æ Services Department responsible for disbursing grant-in-aid, should 决 very careful in this regard to ensure that the above instructions are strictly followed.

 (i) Amount of Dearness Allowance due from the month of January, 1990 shall be paid in cash.

4. Dearness Allowance sanctioned under these orders will also be admissible to those Government employees, who are brought on the revised scales of pay under the Orissa Revised Scales of Pay Bules, 1989 and also to those who have elected to retain the scales of pay which prevailed prior to the 1st January 1985.

5. In case of employees for whom revised scale of pay under the Orissa Revised Scales of Pay Rules, 1981 are yet to be fixed or sanctioned, the Dearness Allowance may be paid provisionally as admissible on pay. The provisional payment of Dearness Allowance will be readjusted when the pay of the employees concerned, is fixed in the revised scales of Pay.

NOTE—For employees drawing pay in Pre-1974 scales of pay, the pay for the purpose of calculating Dearness Allowance shall consist of Basic Pay, Dearness Allowance, 'Additional Dearness Allowance and Interim Relief, if any admissible on such pay as on the 31st December 1973.

6. Dearness Allowance in accordance with these orders will also be admissible to the Government employees, etc., who were in service on the 1st July 1989 but ceased to be in service on the date of issue of these orders.

7. On the body of the Pay Bill, Dearness Allowance should be exhibited separately.

8. These rates of Dearness Allowance and the mode of payment, etc. prescribed in this Office Memorandum shall also apply to the Teachers of Non-Government Primary Schools, employees of Aided Educational Institutions, work-charged employees, employees of Urban Local Bodies and Job-contract employees of Consolidation, Survey and Settlement Organisations.

## OFFIGE MEMORANDUM

Bhubaneswar, the 10th November 1989

Subject—Modification of the procedure laid down in Rule 253 (2) of O. G. F. R. Vol. 1 for regulating sanction of Moped Advance to Government servants.

In terms of the Finance Department Office Memo. No. 8276-F., dated the 21st February 1986 [Laid down in Para. (2) under Rule 253 of O. G. F. R. Vol. I) the State Government may in the public interest sanction an advance for purchase of moped to a Government servant, whose monthly basic pay is not less than Rs. 209 per month, as per Orissa Revised Scales of Pay Rules, 1985.

After careful consideration of the representations received from Class IV employees to relax the existing provision and allow them the advance for purchase of Moped, Governor has been pleased to decide that there shall be no basic pay, limit of the employees for sanction of advance for purchase of moped.

No such advance shall be sanctioned to any employee, who has not cleared up the advance already availed by him for purchase of any conveyance.

All other terms and conditions contained in Finance Department Office Memo, No. 17114-F., Cated the 19th April 1985 will remain unaltered.

This shall be effective from the date of its issue.

The relevant provision of the O.G.F.R., Vol. 1, is being amended accordingly.
