OFFICE MEMORANDUM

Sub: Revision of rate of honorarium of Guest Faculties in MDRAFM, Bhubaneswar.

In supersession of Finance Deptt. O.M. No.18297/F dated 02.05.2012 the rate of honorarium of Guest Faculties of Madhusudan Das Regional Academy of Financial Management(MDRAFM) is here by revised as detailed below:-

1. The rate of honorarium of Guest lecturers per session of 60 minutes/75 minutes in respect of Government officers will be Rs. 1000/- and for other Resource Persons it will be Rs. 1500/- .
2. Government officers who use their office vehicle or hired vehicle provided by the office will not be paid any conveyance charge.
3. Resource persons (other than the persons mentioned at point No 2 above) in twin city will get Rs 500/- as fixed travel allowance and for those who come from outside the twin city Cuttack-Bhubaneswar will be paid as per the actual travel expenses (limited maximum to 2-Tier Rly A.C fare) and Rs.500/- for local conveyance.
4. The rate of honorarium for Experts/ Eminent Resource Persons, invited only for WORKSHOP, SEMINAR, MADHUSUDAN DAS LECTURE SERIES (with due approval of Director, MDRAFM) will be Rs 5000/- MDRAFM will provide free boarding and lodging facilities at Govt. accommodation along with the office vehicle for their to and fro journey. In exceptional cases, a higher honorarium may be considered and the same shall be finalised with approval of Finance Deptt.
5. MDRAFM will obtain feedback from the trainees for guest faculties including in-house faculties on a scale of 1 to 10. Selection/ empanelment of faculties will be done on the basis of such feedback.

This will come into force from the date of issue of this order.
